- 5. Photocopies of this Certificate should be framed and displayed at all conspicuous places in all lobbies/corridors in all floors of all Towers/Blocks of building/premises.
- 6. The maintenance of fire safety installation in the building / premise shall be owner's / occupier's liability as per Rule-16 of OFP & FS Rules, 2017. He shall maintain the same in good repairs and working condition at all times. Any lapses in fire safety installation during fire incident if any shall end with owner's / occupier's responsibility.
